in the twenty Ninth year of the Reign of our Sovereign Lord
George the Second King of Great Britton France and Ireland

County of Orange and Province of New York Geoman of the one part
and Johannas house of the same place of the other part witnesseth
that the Said Rinart House Senor for and in consideration of
the sum of one hundreded pounds to him in Hand Paid By the
Said Johannas House the Receipt Whereof he the Said Rinard house
Doth hereby acknowledge he the Said Rinard House Senor hath granted
Bargained and Sold aliened and Confirmed and By these presents
Doth Grant Bargain alien and Confirm unto the Said Johannas house
his heirs and assigns forever all that message of Land and all that
Peace or Pecul of Land lying Being in the Precinct of Harverston
and County of Orange and Province of New York Butted and
Bounded as followeth that is Begining at a Paperedge tree
By the North west corner of the Land of Christonhouse Runing
South fifty five Degrees west four Chains then Runing South
Seven Degrees west Eight Chain from thence South fifty Degrees
west five Chain and Nineteen Links then South four Degrees
west Seven Chain and forty two Links then South fifteen Degrees
west Seven Chain and Twenty four Links and then west Thirty
Two Degrees North Sixteen Chain and Six Links along the Lane
or Road and then west three Degrees South Twelve Chain
to a Red oak tree and then Runing westerly to the Land of
Jacob Hallsted and from thence Northerly to the South west
corner of the Land of Johannas Blauwell and from thence
Runing an Easterly course along the Land of said Blauwell
to the place first mentioned laid out and Contains two
Hundred and fifty five acres Bet more or less togather
and also all trees wood underwoods tithe Commons Commons
of pasture Profits Commodities Advantages Hereditiments ways waters
and appurtenances and whatsoever to the same Belonging or
in any wise appertaining and also the Reversion Recievs
Remainder and Reminders Rents and Services of the Said
Premises of Every part thereof and all the Estate Right
title Interest Claim and Demand whatever of him the

Land and Premises and Every part thereof to have and to
